The Queen Bee Consignment Agreement

1. The Consignor warrants and represents that he/she is at least 18 years of age, is the owner of all goods consigned to The Queen Bee, LLC and he/she has the legal right to enter into this Consignment Agreement; and that the goods are saleable and/or free & clear of liens, loans, legal proceedings or other ownership encumbrances.
2. The consignment period will be ninety (90) days.
3. **50/50 split:** 50% of the selling price will be paid to the consignor and 50% will be retained by The Queen Bee, LLC.
4. The Queen Bee, LLC reserves the right to determine the actual selling price for all items. That price will not be changed during the initial 30 days. The next 30 days the item will be discounted 15% and another 15% the next 30 days.

5. Consignor acknowledges that The Queen Bee, LLC is not a certified appraiser of antiques and/or collectibles. Every effort will be made to fairly price and profitably consign items based on a number of factors including age, condition, quality, brand name and market prices for comparable merchandise.
6. Consignor agrees that any item consigned to The Queen Bee, LLC may be displayed wherever The Queen Bee, LLC chooses.
7. Consignor acknowledges that The Queen Bee, LLC will have a monetary investment in time, space and advertising in selling consignor items. Consignor agrees not to remove consigned items prior to the end of the 90 day consignment period. If a consigned item is removed prior to the end of the consignment period, the consignee agrees to pay The Queen Bee, LLC a fee of 25% of the asking price of the consigned item plus any additional costs incurred by the consignment.
8. Consignors will be paid by check after their item has sold the following month. You may access your account 24/7 online at **www.queenbeeconsignments.com** to track your sales and payments.
9. Consignor acknowledges that The Queen Bee, LLC maintains fire and liability insurance coverage only. All reasonable care will be taken to ensure the safety of items consigned with The Queen Bee, LLC; however, items are left at the consignor's risk. Consignor acknowledges that The Queen Bee, LLC is open to the public and is not responsible for any loss due to damage, theft or natural disaster, including fire or water damage.
10. It is the responsibility of the consignor to notify The Queen Bee, LLC of any change of contact telephone number or address.
11. Although we cannot guarantee that each item will sell, The Queen Bee, LLC will make every effort to correctly price each item and sell each item consigned within the consignment period.
12. It is the responsibility of the consignor to know when the consignment period expires. Upon expiration of the consignment period, and if the consignment period has not been extended, the consignor has seven (7) days to pick up any unsold items. You must notify us at least one business day in advance that you are coming to retrieve your unsold item(s). The consignor is responsible for finding and pulling their items off the showroom floor and bringing it to the front desk. Unless prior arrangements have been made and agreed upon in writing by both the consignor and The Queen Bee, LLC any item left for more than seven (7) days after the end date (SEE LAST PICKUP DATE ABOVE) of the consignment period will be considered abandoned and become the sole property of The Queen Bee, LLC and will be donated to charity. After 97 days from the consigned date, The Queen Bee, LLC has NO FURTHER OBLIGATION TO THE CONSIGNOR for account inquiries, accounting information or contract settlements.

This Consignment Agreement, along with the attached inventory sheet, constitutes the entire Agreement between the parties.
